#### Agreement Terms and Conditions of Shipping

The prices (or any portion thereof) may not be extended to any other party. Members may not under any circumstances sell, assign or otherwise transfer (including but not limited to, third party billing) the benefit of this pricing to any nonmember. Failure to abide by this provision may result in immediate termination of participation.
- Members must complete this form to participate.
- Each shipment made under this agreement is subject to the terms and conditions of the FedEx Service Guide in effect at the time of shipment and which terms are incorporated into this agreement by reference. FedEx reserves the right to modify the FedEx Service Guide at any time without notice.
- Participation in the agreement is conditional upon obtaining FedEx Credit approval. FedEx reserves the right to deny credit and does not extend consumer credit privileges.
- Payment on member accounts is due 15 days from the invoice date. Duties and taxes are payable on receipt. Failure to comply with payment terms may result in denial of credit and removal of discounts. This agreement will be effective for so long as the supplier agreement between Novation LLC and FedEx remains in effect, or until termination of that agreement, whichever first occurs. However either you or FedEx may terminate this agreement at any time upon sixty (60) days written notice to the other party.
- Members are prohibited from using the FedEx name or logo without the prior written consent of FedEx.
- The member agrees that FedEx may disclose your shipping volume and payment information to Novation and its affiliate at any time to fulfill reporting requirements to Novation.
